With the approval of the Competent Authority and in consultation with the Development Commissioner, VSEZ, as directed, the following officers in the cadre of Superintendent of Central Tax are placed at the disposal of the Development Commissioner, VSEZ, Visakhapatnam for deployment to SEZs against encadred posts in the jurisdiction of Visakhapatnam Zone with immediate effect and until further orders:-

In terms of Board's letter F.No. A/35017/39/2008-Ad.II dated 27.03.2009, the normal tenure of the above officers at VSEZ is for a period of 2 years from the date of their reporting before the Development Commissioner, VSEZ, Visakhapatnam. The extension of the tenure by a maximum period of 1 year in SEZ on completion of normal tenure of 2 years is subject to recommendation by the Development Commissioner, VSEZ, Visakhapatnam and the approval of the Pr. Chief Commissioner / Chief Commissioner of Central Tax and Customs, Visakhapatnam Zone.
- 3. Officers mentioned at Sl No. 1 above, Shri Munagavalasa Srinivasa Rao, Superintendent shall be relieved in Oct 2022 to enable him report before the Development Commissioner, VSEZ, Visakhapatnam against the vacancy that would be created upon repatriation of Shri Tapan Hazra, Superintendent whose tenure in VSEZ expires on 20.10.2022.
- 4. The remaining Superintendents as mentioned at Sl No. 2 to 4 above shall be relieved from their present place of posting by 15.07.2022 and the officers shall report before the Development Commissioner, VSEZ, Visakhapatnam by 18.07.2022. Visakhapatnam CGST Commissionerate is to report compliance of relief of the officers mentioned at Sl No. 2 to 4 by 18.07.2022.
- 5. Further, In terms of Board's letter F.No. A/35017/39/2008-Ad.II dated 27.03.2009, as agreed upon by the Chief Commissioner of Visakhapatnam Zone and the Development Commissioner, VSEZ during the consultative meeting held on 05.07.2022, and in partial modification to EO (GO) No. 05/2022 dated 26.04.2022, as directed, the tenure of the following Superintendents working in VSEZ against encadred posts, has been extended up to the dates mentioned against each as under:-

All Superintendents and in-situ Superintendents who have completed their normal tenure of 2 years at VSEZ, and whose tenure has not been extended at Para 5 above, shall be relieved from VSEZ to enable them report to their respective place of posting by 18.07.2022, as ordered vide AGT 2022 Order EO (GO) No. 05/2022 dated 26.04.2022.
- 8. The officers shall ensure proper handing over of charge with a written brief of pending issues of their respective charges/ sections to the relieving officers.
- 9. All applications in the cadre of Superintendents received against this office circular dated 04.04.2022 for selection of officers to be posted to VSEZ stand disposed with the issue of this Establishment Order.
