MTS at Sl No. 2 above who has not reported to CCO (VZ) is to report Visakhapatnam CGST Commissionerate for administration of Oath before the Additional Commissioner/Joint Commissioner on or before 25-05-2025, except in case the date of joining has been extended by the Principal Commissioner of Central Tax, Hyderabad CGST Commissionerate (CCA), Hyderabad. Upon completion of joining formalities, Visakhapatnam CGST Commissionerate is to relieve the MTS to enable him join at his place of posting.



The pay & allowances of the above officers will be drawn by the DDO Visakhapatnam CGST Commissionerate from the date of joining in the cadre of Mult-Tasking Staff. All service matters of the above officers would be handled by Visakhapatnam CGST Commissionerate.

Visakhapatnam CGST Commissionerate is also requested to verify Original Education/Caste/PH Certificates of MTS at Sl No. 2 above while administrating Oath and also obtain any other documents as may be required by the Principal Commissioner of Central Tax, Hyderabad CGST Commissionerate (CCA), Hyderabad.

6. All other terms and conditions mentioned in EO (NGO) No. 30/CCA/2025 dated 24.04.2025 issued by the Additional Commissioner of Central Tax, Hyderabad CGST Commissionerate (CCA), Hyderabad remain unaltered.
