2. As per the order of the MHA dated 30.06.2020, lock down period has been extended for a further period upto 30.06.2020, relevant portion of the said order is reproduced as under:

"Whereas, in exercise of the powers under section 6(2)(i) of the Disaster Management Act, 2005, National Disaster Management Authority (NDMA) has

directed the undersigned to issue an order to extend the lockdown in Containment Zones upto 30.06.2020, and to re-open prohibited activities in a phased manner in areas outside Containment Zones;

Now therefore, in exercise of the powers, conferred under Section 10(2)(1) of the Disaster Management Act 2005, the undersigned hereby directs that guidelines, as Annexed, will remain in force upto 30.06.2020."

3. As per the MHA new guidelines dated 30.05.2020, it is brought to the notice that, Lockdown measures would continue to be implemented strictly in the Containment Zones. These will be demarcated by the State/UT Governments, after taking into consideration the guidelines issued by the Health Ministry. Within the containment Zones, strict perimeter control shall be maintained and only essential activities allowed.

4. In view of the above referred notices/orders/guidelines, issued from time to time and by the Collector & District Magistrate, Guntur District vide reference (q) above and as per S.No.14 of the statement showing the particulars of the Containment Zone i.e. **Kannavari Thota**. As per which, the **Office of the Commissioner of Central Tax, C.R.Buildings, GST Bhavan, Kannavarithota, Guntur - 522 004. (Election Ward No.23)** is comes under **Containment Zone**.

5. Further, it is also brought to the notice that, within the containment Zones, strict perimeter control shall be maintained and only essential activities allowed as per new guidelines issued by the MHA dated 30.05.2020.

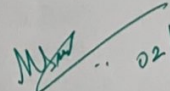
6. Accordingly, the Central Tax Office located in Kannavarithota, Guntur shall closed from 03.06.2020 to 30.06.2020, **or until removal of the areas in which the above Office is situated from "Containment Zone" or orders if any issued in this regard.**

6.1 All the Officers and Officials should monitor and work online from their homes, if warranted.

6.2 All the Officers and Officials should not come to Office during the above period unless there is some emergency in Office which will be informed as and when necessary.

6.3 All the Officers and officials should be available on mobile/telephone during the above period for the purpose of information and action; & should remain in headquarters.
