## ORDER 04/2024-2025 (UNDER THE RIGHT TO INFORMATION ACT,2005)

Where as Sri. Brahmaiah (here in referred to as the 'Appellant') has filed an Appeal Dated.08.01.2025 vide Registration No CECVZ/A/E/25/00003 under Section 19(1) of the RTI Act,2005 before the First Appellant Authority (FAA), Guntur to his RTI Application dated.08.01.2025.

- 2. As seen from the original RTI Application dated.20.12.2024, the Appellant has sought the following information.
- "Shop no 6969, old cinema hall center, penuganchiprolu, NTR District Andhar Pradesh-521190, for this shop 6969 how the rent paid since 2021 to 2024, who has received the cheque or bank? Which account amount has been registered or not? approval details, income and expenditure details".
- 3. With reference to the above RTI, and since no particulars was given in the RTI application with regard to registration no of the shop, the CPIO has given the reply dated.02.01.2025 stating that " the information sought by you is ot available in this office and requested the seek the information from the owner of the shop"
- 4. The Appellant upon receipt of the above reply from the CPIO, Guntur, has filed an appeal vide letter dated.08.01.2025 vide Registration No CECVZ/A/E/25/00003 before me requesting for submission of following information.
- " in the YSR government has allocated the shops to penuganchiprolu, how many shops allocated? how do you make the rent payment? Agreement details? shop details and address? allocated persons names and rent paid

person names and required all details".

- 5. As seen from the above, the details sought by the applicant in their first RTI dated.20.12.2024 are irrelevant to the Information sought by the applicant in the Appeal.
- 6. As per the Principals of Natural Justice, the Appellant was given an opportunity for personal hearing on 28.01.2025 at 12.00 pm in the Office of the Commissioner of Central Taxes, Guntur CGST Commissionerate, GST Bhavan, Nagarampalem Guntur to put forth his appeal.

## Personal Hearing:

The Appellant has not come up for the personal hearing at the given date and time

## **FINDINGS**

- 5. I have gone through the Appellant's RTI Application dated. 20.12.2024, the information furnished **CPIO** vide by file F.NO.GEXCOM/RTI/RTPS/1/2025 vig dated.02.01.2025, Appeal letter dated.08.01.2025. The Appeal filed by the Applicant vide letter dated.08.01.2025 vide Registration No CECVZ/A/E/25/00003
- 6. The information sought by the applicant in their first RTI dated.20.12.2024 in Registration No CECVZ/R/F/24/00081 is different from the information sought by the applicant in the Appeal dated.08.01.2025 in Registration No. CECVZ/A/E/25/00003.

Hence, the appeal is rejected and accordingly disposed off.

The Appeal against this order would lie before the Commissioner of Central Information Commissioner, 2<sup>nd</sup> floor, C-Wing, August Kranti Bhavan, Bhikali Cama Place, New Delhi-110066 and if agreed, the same may be filed within ninety days from the date of receipt of the order communicating the decision of the FAA.
