TRADE NOTICE

Subject: Re-organisation of existing CGST executive Commissionerates of
Visakhapatnam Zone.

Consequent upon change in jurisdiction of Revenue Districts in the state of Andhra Pradesh, the Government of India vide Notification No. 39/2023 dated 17-08-2023 has notified the revised territorial jurisdiction of the existing CGST Executive Commissionerates of this zone w.e.f. 04-04-2022.

2. The jurisdiction of the Commissionerates, Divisions and Ranges of Visakhapatnam CGST Commissionerate, Guntur CGST Commissionerate and Tirupati CGST Commissionerate are as per Annexure – I, II and III respectively. Further, the jurisdiction of Guntur CGST Audit Commissionerate and Guntur CGST Appeals Commissionerate will be same as mentioned in Trade Notice No. 01/2017 dated 12-06-2017 issued by this office.

3. The trade notice will come in effect from 04-04-2022 and will continue until any changes are notified by the Department.

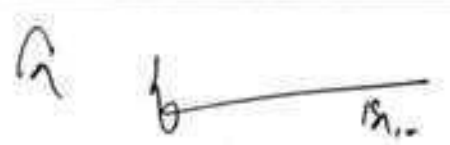
