Generally officers from the cadre of Gr. B executive (Inspector and Superintendent) are being deployed to work in PRO section and he/she is designated Superintendent(PRO)/Inspector(PRO) which is similar to other officers deployed in various sections viz. Superintendent(Gate Officer), Superintendent(Assessing Officer), Superintendent/Inspector(Recovery Officer) etc. Hence PRO is nothing but Superintendent or Inspector only.
- 2. In this regard, as sought information point wise replies to your application are furnished hereunder-
 - **Point No. 1-** As per records there are no separate sanctioned posts in the cadre of superintendents and Inspectors to work as 'PRO'.

 - **Point No. 6-** The performance of an officer, including PRO is recorded in the Annual Appraisal Report of the individual, which are maintained by all
