For the Financial Year 2023-24, tax collection in respect of the taxpayers falling under the Central Tax jurisdiction is: Rs. 24,850.65 Crores.

For the Financial Year 2024-25 (upto June 2024), tax collection in respect of the taxpayers falling under the Central Tax jurisdiction is: 7,112.60 Crores.

(ii) On which products the tax will be collected:

The tax will be collected on all the taxable items coming under each slab, as prescribed under the Notification No. 01/2017- CT(Rate) dated 28-06-2017 [for goods] (as amended from time to time) and Notification No. 11/2017-CT(Rate) dated 28-06-2017 [for services] (as amended from time to time) & they may be referred for the list of taxable items.

2 . In this connection, the information as sought by you in above RTI application is provided below:

(i) How many type of GST slabs are there:

There are six main CGST slabs in India as per the Notification No. 1/2017-Central Tax (Rate) dated 28-06-2017 (as amended from time to time):

- 2.5%: in respect of goods specified in Schedule I;
- 6%: in respect of goods specified in Schedule II;
- 9%: in respect of goods specified in Schedule III;
- 14%: in respect of goods specified in Schedule IV;
- 1.5%: in respect of goods specified in Schedule V; and
- 0.125%: in respect of goods specified in Schedule VI.

(ii) What are the items included in each type of slabs:

For the list of taxable items under each slab, the Notification No. 01/2017-CT(Rate) dated 28-06-2017 [for goods] (as amended from time to time) and Notification No. 11/2017-CT(Rate) dated 28-06-2017 [for services] (as amended from time to time) may be referred .

(iii) What are all the items excluded from GST:

For the list of items excluded from CGST, the Notification No. 02/2017-CT(Rate) dated 28-06-2017 [for goods] (as amended from time to time) and Notification No. 12/2017-CT(Rate) dated 28-06-2017 [for services] (as amended from time to time) may be referred .

(iv) Are there any other taxes other than GST:

The following are the indirect taxes other than GST :

- Customs Duty: Levied on goods imported into India.
- Excise Duty: Applicable on specific goods like Petroleum Crude, high speed diesel, motor spirit, natural gas and aviation turbine fuel.
