

- (a) THE QUANTUM AND VALUE OF MINERALS AND METALS INCLUDING IRON ORE
AND THEIR PRODUCTS EXPORTED AND IMPORTED FROM THE COUNTRY DURING THE
LAST THREE YEARS, COUNTRY-WISE ALONG WITH THE COUNTRY'S SHARE IN
WORLD TRADE OF SUCH MINERALS AND METALS;
- (b) THE PERCENTAGE OF EXPORT VIS-À-VIS THEIR PRODUCTION IN THE COUNTRY;
- (c) WHETHER INSTANCES OF ILLEGAL EXPORT OF SOME MINERALS, PARTICULARLY
IRON ORE HAVE COME TO THE NOTICE OF THE GOVERNMENT AND IF SO, THE
NUMBER OF SUCH CASES REPORTED DURING THE SAID PERIOD ALONG WITH THE
FOLLOW UP ACTION TAKEN BY THE GOVERNMENT THEREON; AND
- (d) WHETHER THE GOVERNMENT PROPOSES TO REVIEW THE EXISTING POLICY
WITH RESPECT TO MINERALS AND METALS, PARTICULARLY IRON ORE SO AS TO AS
