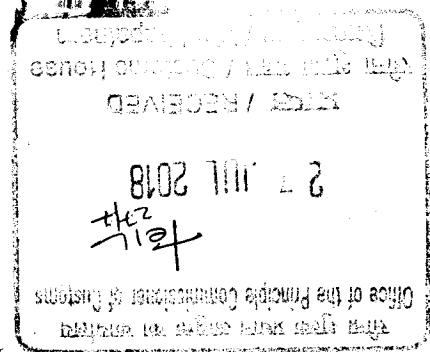

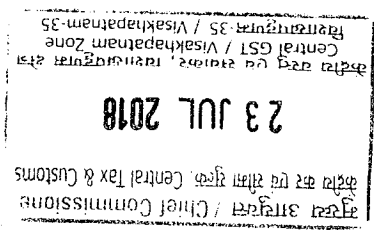
In this regard kindly furnish the following acting information through RTI Act to the above mentioned Address.
