Namarla. Satyanarayana revealed secret that he has given huge amount to Assistant Commissioner of Customs (CIU) Sri. Dipak Zala to hide his surname & Caste to Police authorities.

Under the influence of Namarla.Satyanarayana, Assistant Commissioner of Customs (CIU) Sri.Dipak Zala has issued the hand writing of Namarla.Satyanarayana (ST - Konda Dhora) on surname "NAMALA" to Sri. R.Someswara Rao, Sub-Inspector of Police - Vth Town / Visakhapatnam

Assistant Commissioner of Customs (CIU) Sri. Dipak Zala helping him to maintain Two surname & Two Castes to cheat Hon'ble Courts, Registrar Offices, Police Authorities & Customs Organisation. On this allegation I gave a Complaint on dt:11.09.2018 to the Chief Commissioner of Customs/VSKP.

Kindly furnish the following asked information through RTI Act to the above mentioned address.

- Copy of action taken on Assistant Commissioner of Customs (CIU) Sri.Dipak
 Zala on issuing the hand writing of Namarla.Satyanarayan (ST) on surname
 "NAMALA" to SI-Vth Town Police station/VSKP.
- 2. Copy of action taken on Namarla. Satyanarayna (ST) who is cheating the Customs Organisation with False surname & False Educational Certificates.
