Sub: Abused discretionary powers by Shri D.K. Srinivas, Principal Commissioner of Customs, Visakhapatnam by sudden suspension of Senior Superintendent Namarla Satyanarayana who has completed 34 years of service and who is on leave and during nationwide Strict Lockdown of 3<sup>rd</sup> phase basing on mere family undivided property dispute among brothers which are subjudiced in Hon'ble HighCourt of Andhra Pradesh vide WP No.31545/2016, dated 28.08.2016 – Request for look into the matter and justice.

My brothers had disputed with me during dividing share of property acquired by my father late Namarla Venkata Rao son of Paradesi levelled false and fabricated allegations and complained to the Commissioner of Customs on 12.11.2015 for taking necessary action. Afterwards, my brothers were filed case in Hon'ble High Court of Andhra Pradesh vide WP No:31545/2016, dated 28.08.2016 stating that, the complaints todged to the Commissioner of Customs, Visakhapatnam had not been taken any action. The case is still pending before the Hon'ble High Court till today.

During availing earned leave on ill health grounds i.e. from 11.03.2020 to 30.05.2020 a letter vide F.No.S20/12/2015-CIU (Vol-II), dated 16.04.2020 sent through WhatsApp by Shri K. Saravana Kumar, Dy. Commissioner (CIU) stated that, in connection with a complaint received, asked me to appear before him on 22.04.2020 at 11 am with copies of non-mandatory documents viz. Aadhar Card and Driving Licence obtained from Road Transport Authority only. Informed over phone my disability due to swelling of left knee and could not approached the Dy. Commissioner (CIU) on 22.04.2020. On the same day i.e. vide even no., dated 22.04.2020 one more letter had sent through WhatsApp directed me to approach Dy. Commissioner (CIU) on 24.04.2020 at 3 pm without fail. This time also I could not approached the Dy. Commissioner (CIU) due to severe pain in left knee.

All of sudden on 04.05.2020 i.e., the 1<sup>st</sup>day of 3rd phase of nationwide lockdown announced by the Hon'ble Prime Minister of India appealed general public and government employees not to come out of homes who are above age of 50 years, sick and vulnerable, an order of suspension of service sent through WhatsApp vide F.No. S20/15/2020-CIU, dated 04.05.2020 during crisis which is unwarranted and illegal (Copy of Suspension Order is enclosed).

After suspension from service, one more letter even no. dated 21.05.2020 sent through WhatsApp directed me to appear before Dy. Commissioner (CIU) on 27.05.2020 at 11am. By the time I was able to walk due to little recovery from swollen knee I approached the Dy. Commissioner (CIU) on 27.05.2020 at 11 am and submitted the non-mandatory copies of Aadhar Card and Driving Licence obtained from Road Transport Authority.

enquire till evening asking the questions are all pertaining to sub judiced matters in Hon'ble High Court of Andhra Pradesh vide WP No:31545/2016, dated 28.08.2016 pending for disposal (A copy of Paper Book of WP No:31545/2016, dated 28.08.2016 is enclosed for kind perusal). High Court of Andhra Pradesh since 2016 and never called me or issued any letter so far on this matter till happening of above circumstances. All of sudden created above unwarranted situations hurrily during the leave period of an employeeon ill health grounds and during strict Lockdown imposed nationwide by the Hon'ble Prime Minister of India for preventing outbreak of Novel Carona Virus 2019 pandemic is unwarranted and is a clear case of collusion with complainants. This is a mere case of family property dispute which was sub judiced in Hon'ble

justice by revoking the suspension order issued illegally. In view of the above, I humbly request the authority to look into the matter and do


