above subject for kind perusal.

I was suspended on 04.05.2020 on the grounds of contemplated
disciplinary proceedings for a period of 90 days and subsequently, extended
twice i.e. on 02.08.2020 and 31.10.2020 with duration of 90 days each. I filed
a case against the continued suspension in the Hon'ble Central Administrative
Tribunal and the Tribunal had set aside the initial suspension and subsequent
extensions and ordered for posting. The disposal of the case had took place on
10.11.2020 and the copy of order received on 16.12.2020.


Afterwards I got promotion as Asst. Commissioner vide Board
Office Order No:156/2020 vide F.No:32012/13/ 2020-Ad.II, dated 24.12.2020
but the suspension was not revoked and extended further for 45 days from the
expiry of the existing suspension by the time and Charge Memorandum was
also issued by the Principal Commissioner of Customs, Visakhapatnam vide
F.No:S20/15/2020-CIU (Vol-II), dated 04.02.2021.

In this connection, I humbly submit the Hon'ble Central
Administrative Tribunal, Hyderabad Bench judgment. This is for your kind
information and necessary action please.
