In terms of Board's F.No.A-11019/5/2017-Ad.IV dated 16.06.2017, the posting to DGGI, Zonal unit, Vizag/DGGI, Regional Unit, Vijayawada is on local transfer basis (from the sanctioned strength of CCO) for a period of two years from the date of joining in the Directorate. The pay & allowances of the officers posted to the Directorate will be drawn by the DDO, Visakhapatnam CGST Commissionerate. Officers posted to DGGI, VZU may be further distributed between VZU and VRU as per requirement by the Directorate.
