4. The officers will continue to draw their salary and allowances from their parent Commissionerate.

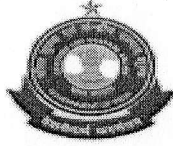


